## Mayor's Lips Are Sealed Councilman Resigns

Some wanted an explanation, while others asked for the Mayor to be removed from office or simply resign from his position; but both citizens and city council members went home with their questions unanswered, as the mayor's lips were sealed about what he deemed as the on-going investigation of the former Eagleville city recorder. Citing he was under the advice of counsel, Mayor Barham remained unresponsive, as he came under fire during the March city council meeting.

During citizen's input, Donna Jensen, who was a candidate in the last city election, asked the mayor to "step up and be accountable" and to give the citizens an explanation, or to "graciously step down".

Jensen maintained that the city has suffered from yet another public embarrassment, despite complaints and warnings about the former city recorder that were largely ignored.

Councilman Sam Tune, who has become known for his no-nonsense, "shoot straight from the hip" approach, asked Mayor Barham to address 11 issues surrounding the investigation, misconduct, gross negligence, and conflicts of interest.

"I would never ask anybody to jeopardize themselves and not follow the direction of the TBI or the Attorney General. The 11 specific issues I want to discuss is public knowledge and has no impact on the investigation whatsoever," said Councilman Tune during his address to the mayor.

## Country Music Legend Replaced By Cyber Disc Jockey

Keith Bilbrey, a country music radio legend, was suddenly dismissed from his duties after 34½ years from WSM 650 AM Radio and 24 years at the Grand Ole Opry earlier in the month. The WSM 650 management claims that due to economic hard times, his position as mid-day air personality would be eliminated. Bilbrey will be replaced with a cyber disc jockey (pre-taped music) and will no longer carry the Classic Café that was a favorite among lunchtime fans. Management at the Grand Ole Opry told fans that they had made a new rule of hiring only active WSM employees and he was no longer needed as one of the announcers. WSM's call letters "We Shield Millions" shielded other announcers such as Grant Turner & Hairl Hensley in the past when both were allowed to remain at the podium after leaving WSM Radio. Bilbrey held "seniority" status at both occupations.

Bilbrey was allowed to return to the podium for one last show at the Grand Ole Opry on Saturday, March 14, 2009 where Marty Stuart called him to center stage to recognize him for his 34 years. The audience gave him a standing ovation but it was obvious that management was not present onstage for his recognition. That night's lead story on WSMV-TV Channel 4,

## Highlights from the City Of Eagleville Council Meeting Thursday - March 26, 2009

### Citizen's Input

1. John E. Turner wanted an explanation from the Mayor surrounding the investigation of the former city recorder and wanted to know if he personally signed the check or if it was done with a rubber stamp. Turner requested that each question be addressed tonight while everyone was in attendance. Turner asked if the \$800 the Mayor used for advertising were his, would he still have used it for that purpose.
2. Former council member, Greg Buchanan, asked the council to consider beginning the process that could remove the Mayor from office due to willful neglect of his duties.
3. Craig Sewell wanted to know if he could delay his input until further into the meeting that pertained to him.
4. Donna Jensen requested an explanation regarding the former city recorder since the investigation is now over.
5. Phil Williams said that he had written months ago and had addressed the city council surrounding the request for the mayor's resignation.

### Financial Report

- Adoption of the January and February financial reports passed by a vote of 3-1, with Councilman Ball voting against. Apparently, there was an oversight in last month's council meeting in which the financials for the month of January were not approved.

### Park Report

- Vice-Mayor Hill said that he had spoke with Jeff Mooneyham and that the first games of the new ball season are slated to begin April 17th, 2009. He said the concession stand would be up and running for anyone wanting to stop by to grab a hamburger.

### Fire Report

- Fire Chief Martin, who was vacationing with his family, was not in attendance, but City Recorder Colleen Adams read a statement on his behalf.
- City Recorder Colleen Adams reported that the fire department had not had many fire calls this month, but had responded to a gas leak on Hwy. 41-A and a motor vehicle accident, as well as a woods fire on Bunker Hill Rd. The volunteer fire department currently has 18 firefighters on the department and approx. \$13,000 in the bank.

- Vice-Mayor Ronnie Hill wanted the council to be aware of a bill from the Eagle's Roost, in which the fire department dined on 3.10.09 after a fire call. Chief Martin requested the bill, which was \$74.38, be billed to the fire department.
- Vice-Mayor Ronnie Hill also added that he wanted the council to be aware of expenditures at Wal-Mart for Pepsi's, Mtn. Dew's, Peanut Butter Crackers, etc. totaling \$27.
- Councilman Alan Ball wanted to know if the fire department had made a change in their insurance coverage. City Recorder Colleen Adams stated that there were not enough fire departments to switch over in order to get the pricing that was originally quoted.
- Councilman Tune suggested that some type of guidelines be put into place regarding the current expenditures on food, since the fire department's money is still regulated by the city.
- Mayor Barham stated that there had been a lot of problems with the computers this week. City Recorder Colleen Adams will be saving the city \$100/month by changing Internet providers.

### Police Report

- Mayor Barham gave the police report since Councilman Fitzgerald was not present. Mayor Barham stated that City Recorder Colleen Adams has filled out a lot of the grant application form and that he would be getting with her next week to complete the narrative. Once the grant application is complete, copies will be distributed to the council. There are only 3 weeks left in which to submit the grant by its deadline.
- Councilman Ball was able to secure a financial statement for the Chapel Hill police department.

### Zoning Report

- Councilman Ball asked if the City of Eagleville still owned a 10x92 piece of property across the street from city hall. Mayor Barham explained that it was being looked into.
- In regard to complaints, Lichtenberger stated that requests could come from anyone, as there are people who do business in the city but do not live in the city. "Requests for services should be accepted in any manner," explained Lichtenberger. She also explained that she does not even ask that the person

## Eagleville Moves One Step Closer To Reinstating Its Police Department

The City of Eagleville is moving one step closer to reinstating its police department by applying for funding under the COPS Hiring Recovery Program (CHRP). The Office of Community Oriented Policing Services (COPS Office) recently received additional funding from its original \$1 billion appropriation through the Omnibus Appropriations Act, signed into law on March 11th, 2009.

CHRP is a competitive-based grant program that does not require a local match, and provides 100 percent of funding for new hires that are full-time, sworn officers, or for rehires who have experienced lay-offs centered around budget cuts. The funding is also available in the prevention of police force reduction due to a lack in local funding.

The grant provides funding for a full 36 months, or 3 years, but does require the retention of the new hires for a one-year period after the 3 years are up. Additionally, there is no cap on the number of requested positions.

The Eagleville City Council was recently informed of the CHRP grant opportunity by Councilman Fitzgerald, through a called meeting on March 17th, 2009; only 2 days into the grant's application availability. Fitzgerald, who has spearheaded a feasibility study on the potential reinstatement of the city's police department, informed the council of the grant's tight deadline, which is April 14th, 2009.

Urgency at reinstating a local police department can be felt throughout Eagleville's downtown businesses, especially by Paula Tipton, the branch manager of Regions Bank; who has experienced two local robberies.

Although unable to attend the called meeting, Tipton reiterated the need for daily police presence, through a written statement, saying, "Please continue to explore all options available to the city to make this protection a reality."

The Eagleville Police Department has been in an inactive status, ever since its former Police Chief, Everett Stone, was placed on administrative leave, and then later retired at the end of a probe by the POST commission.

The POST commission found that Stone did not meet minimum POST commission standards, which would require him to successfully complete training at a basic police school to become a POST certified officer in the state of Tennessee. Since then, the Rutherford County Sheriff's Department has been providing police protection in the Eagleville area.

Should the city of Eagleville receive funding from the CHRP grant, it is required that each new hire be a POST certified officer. The city of Eagleville has received funding from the CHRP grant before, in which its funds were utilized to fund the position of former Eagleville police officer, Charlie Holt.

Due to recent resignation of Councilman Harold Vincion,  
a seat is now open on the Eagleville City Council.

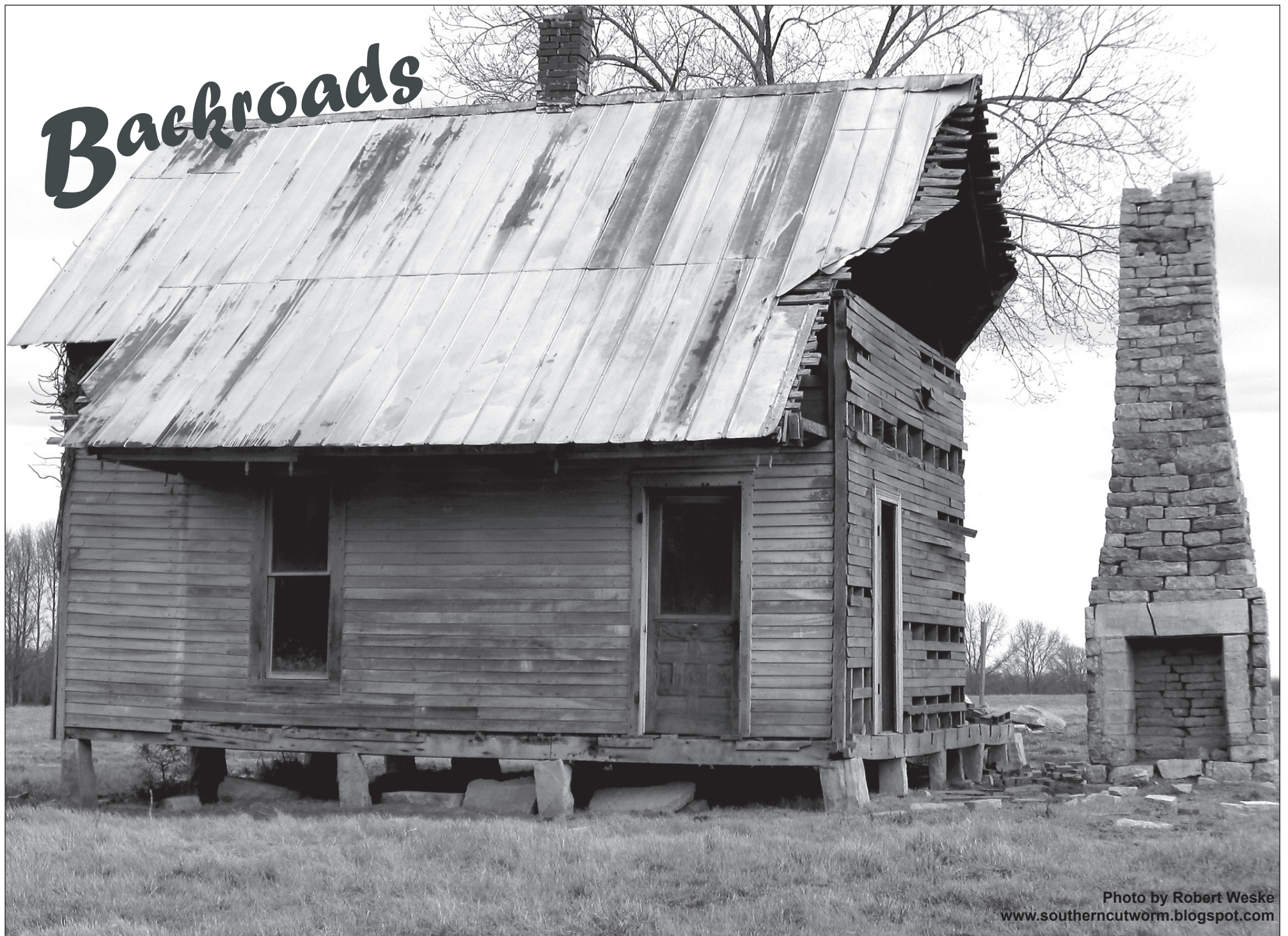
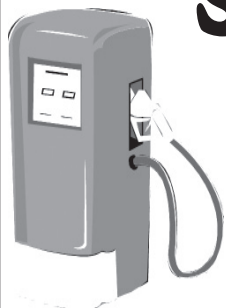

The 11 mayoral issues, which Councilman Tune said were “plain and simple” and hoped to have addressed, were:

1. Violation against Ordinance 06-05: Personnel Policies and Procedures
2. Failure to adequately separate duties of the office personnel
3. Failure to fill planning commission vacancy for more than a year
4. Failure to adequately supervise city employee
5. Knowingly allowed an uncertified police officer, who also served as police chief, to work full-time; knowingly signed checks of a police officer who did not meet state qualifications
6. Violation against Ordinance 07-03: Code of Ethics concerning vote on Eaglecrest III subdivision plat changes.
7. Violation against Subdivision Ordinance by failure to require road bond and appearing untruthful when questioned by a councilman about the bond.
8. Misrepresentation of “Health Savings Account” for city recorders.
9. Failure to provide Councilman M.A. Smitty credit card records as requested
10. Failure to timely notify councilman when auditor presented information on unusual bookkeeping by city recorder.
11. Failure to prepare inventory of city property as required by State Comptroller’s Investigative Audit.

At the end of Councilman Tune’s address, he asked for the mayor’s resignation. “In order to prevent shame, embarrassment, a public hearing, and investigations, I, Councilman Sam Tune, ask you to turn in your cell phone, your keys, any other possessions you have and resign immediately.”

Although there was no response from Mayor Barham, Councilman Harold Vincion offered his resignation. “This really bothers me and it’s gone

on too long. But, you know, we have 3 other sitting members that was on the city council at the same time and I’m confused that you don’t ask for everybody’s resignation other than just the Mayor.”

Councilman Tune explained that he had not asked for anyone else’s resignation, as it was the mayor who had “sole administrative and financial duties to the city”.

Still, Councilman Vincion insisted on resigning, “I hope in 10 years or 12 years from now when ya’ll are on city council that ya’ll are not judged as harsh as some of us have been judged.” Councilman Tune countered, “I hope I’m judged harder and the money is accounted for.”

Councilman Vincion, who declined comment, leaves the Eagleville city council, having served for 17 years. He represented the council on the Eagleville Volunteer Fire Department board, as well as the Planning Commission, which he had been a member of since its inception.

According to the city charter, a majority vote of the remaining city council is required to a fill a vacancy. It is uncertain at this time who will be appointed to fill the unexpired term of Councilman Vincion, whose seat would have been up for re-election in November of 2010. Those interested may contact city hall in advance by calling 274-6992 and by attending a special called meeting Tuesday, April 7th, 2009 at the Eagleville City Hall 6pm.

Vice-Mayor Hill also encouraged Mayor Barham to address the issues, citing a major credibility problem that has seemed to transpire in the past few years. “Your lack of answers to these questions seems to make it even worse,” said Hill. “It just looks like that you do have something to hide, and if you would just come out and answer the questions as best you can, tell the truth, and let the cards fall the way they will.”

Vice-Mayor Hill’s comments finally sparked a somewhat generic reaction from Mayor Barham. “We just had an outline right there, we just heard the detailed report; the attorney will take care of it from there.” It is unclear at this time if the legal counsel being received by Mayor Barham is from the city attorney or Barham’s personal attorney.

filing the complaint to identify themselves.

- Councilman Vincion felt a name and telephone number should be introduced with all complaints. Lichtenberger said that she would do further research to see what policies have been set forth in the past, and will see what neighboring communities the same size as Eagleville does.

### Investigation Update

- City Attorney Adam Dodd was not in attendance at the meeting, so Mayor Barham gave the investigation update on his behalf. Mayor Barham said that the Bond has been revoked; the investigation is not over and will continue until June 8th when the sentencing is to be held, and further discovery could be presented.

- Mayor Barham stated that there would be no report on any of the 11 issues as requested by Councilman Sam Tune because of the aforementioned reasons.

### Councilman Sam Tune's Request for Mayor Barham to Address the Issues Surrounding the Investigation, Misconduct, Gross Negligence, and Conflict of Interest

### Report From Planning Commission

- Upon Councilman Vincion's resignation, Mayor Barham gave the report from the planning commission. Mayor Barham stated that a new city planner has been hired, and her name is Amy Miller.

- Mayor Barham also reported that a minor subdivision plat has been approved for Craig Sewell.

### Sewer Feasibility Study

- Councilman Tune informed everyone that the engineers are working diligently to devise a feasible system for the city of

Eagleville. He also referenced a letter the city received from the engineering company regarding the hiring of a soil consultant (Randy Dickerson) to examine the 20 acres the city owns and that the engineering firm will be paying them \$3,200.

- Councilman Tune did speak with soil consultant, Randy Dickerson this past week, who said that he was shocked and surprised at how much good soil the city of Eagleville had, and was more encouraged than ever before about the feasibility of the sewer system.

- Councilman Tune reassured everyone that all details regarding this project would be made available as soon as they came along.

### New Business- Proposed Resolution To Establish Beer Board to Allow Sales of Beer

- Councilman Sam Tune proposed for the city council to come up with a resolution to establish a beer board. The beer board would be vested in authority to issue or deny or revoke permits to sell beer as provided by the laws of TN and accordance of the rules adopted by the city.

- Sewell, who will be building a new grocery store in Eagleville, explained beer sales would bring additional tax revenues to the city and would help offset the cost of employees. The grocery store, Sewell explained, would create at least 5, but possibly 6 full-time, salaried positions.

- Mayor Barham said the attorney wanted him to relay that establishment of a beer board would have to be done by ordinance and he would like to host a work session to set an ordinance up.

### Mayor's Closing Remarks

- Mayor Barham explained that the auditor would like to meet with the council this summer, in order to get this past year's audit out of the way, then have a meeting with the council again in the Fall.

### Would you Wrestle An Alligator?

Would you jump in a pen and wrestle a half crazed alligator? Probably not! Well,

March was National Colorectal Cancer Awareness Month, and according to the Centers of Disease Control and Prevention (CDC) colorectal cancer is the second leading cause of cancer related deaths in the United States. The sad thing is that in 60% of the cases colorectal cancer is preventable with routine screenings.

So, who is at risk for colorectal cancer? You are considered to be at average risk if you are 50 years old or older with no other risk factors. Men have an average lifetime risk of colorectal cancer of about one in seventeen; whereas, women's risk is about one in nineteen. People at higher risk are those with a close family member such as a parent, sibling or child who has had the disease, or if they have had colorectal cancer or precancerous polyps before. Race also plays a significant role. Blacks are more likely than any other racial group to develop colorectal cancer and have lower survival rates. Most healthcare providers agree that if you're black screening should start at age 45 instead of 50.

It is thought that a high fat, low-fiber diet can increase your likelihood of colorectal cancer. Obesity, diabetes, and heavy alcohol intake can also increase your risk. A sedentary lifestyle can also put you at a higher risk, as well as the good health nemesis-smoking! It has also been shown that people of Ashkenazi ancestry (Jews of Eastern European decent) are more likely to develop colorectal cancer. In 2006, in Poland it was found that men were

more likely to have larger polyps at a younger age and the study's authors recommended screening begin at age 40 for men.

Signs and symptoms of colorectal cancer usually do not appear until the disease has progressed to the advanced stages which also reduce your chances of a cure. When polyps and early stage cancers are found and removed before symptoms are noticed, you increase your five year survival rate by 90%. Symptoms include: a change in bowel habits, including diarrhea or constipation; narrow, pencil-thin stools; rectal bleeding or blood in your stools; persistent abdominal pain, gas, cramps or discomfort; feeling that your bowel doesn't empty completely; or unexplained weight loss. These symptoms could have many different meanings to your health, so you should seek the advice of your healthcare provider if you experience any of the above symptoms.

You might have a chance of taking that half crazed alligator by the tail and smacking him on the nose a time or two and escaping with a few minor scratches, but why take the risk? You could also never get tested for colorectal cancer and never contract the disease. However, I personally wouldn't take my chances with either. A bite in your tail in either case could mean a lot of pain and suffering that could have been prevented by using a little common sense. Take your life by the tail-be proactive, know your risks, don't play the odds, and get tested. It may simply save your life.

# Get Ready for Spring at the Eagleville FFA Plant Sale

The greenhouse at Eagleville High School is bursting with color, as the Eagleville FFA gets ready to throw open its doors for the annual spring plant sale.

The greenhouse is truly alive with vibrant colors from the hundreds of healthy and robust flowers that will be available at the upcoming sale. And at \$12 a flat, the selection won't last long.

While the sale is only right around the corner, students in Mr. Brian Lewis's Greenhouse Management program have been preparing for the spring plant sale as early as late September, when they started growing the Boston ferns, while other flowers, such as Geraniums were started before the Christmas break.

Lewis, who teaches the Greenhouse Management class at Eagleville High School, often finds himself in the greenhouse 7 days a week. As Lewis watered all of the hanging pots of wave petunias overhead, he explained, "The students have worked really hard on this and I hope they have learned something from it, plus it benefits the community, which is important for any agriculture program."

"The Greenhouse Management class really shows students career opportunities in Ag that they have

never thought of before", explained Lewis. "The goal of the class is to enable each student to experience the production, business, and marketing aspects of a greenhouse and to be able to leave here and operate one of their own one day."

Lewis says that annual sales, such as the spring plant sale, help to make the Horticulture program's greenhouse self-supporting. There are 2 other sales during the year, with plans of expanding the Fall Mum sale already, by growing an additional 100 pots of mums. The mums, which are grown adjacent to the greenhouse, were a tremendous hit last fall, with the FFA selling 300 pots. There is also a Poinsettia sale during the holidays.

Lewis, an Eagleville High School alumnus, is co-advisor for the Eagleville FFA chapter, alongside Bruce Hayley, and also teaches an Exterior Landscaping class and Agriscience class; which is offered to incoming freshmen. Agriscience teaches science from an agricultural perspective, which Lewis finds many students are better able to identify with. Freshmen who enroll in Agriscience are able to gain 2 credits, (a science and an agriculture), upon successful completion.

The greenhouse has also proven to be a great asset for other students

at Eagleville School. "We try to collaborate as much as we can with the younger classes", said Lewis. The Kindergarten class was able to plant sunflowers, transplant marigolds, and each student also got to take a plant home with them, as a recent trip to the greenhouse correlated with their study of plants.

Should the funding become available, Lewis hopes to expand the school's Horticulture program, with the addition of another greenhouse. The new greenhouse would create the space needed to host a 12,000-gallon fish tank to grow Tilapia in. The Tilapia would also be sold, as part of an aquaculture program. The new greenhouse would also allow room for the production of hydroponics vegetables; although this year's spring plant sale features 12 different types of traditionally grown tomato plants.

The sale is slated to begin April 6th at 8 a.m. and will continue through Saturday. Proceeds from the sale benefit students in the agricultural education program. Please see the adjacent ad for specific times and a listing of all the great plants available.

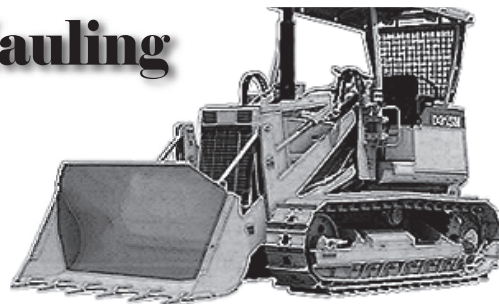

Bilbrey told the newscasters that he couldn't be bitter towards a company that had let him live his dream since he was 6 years old. He admitted to *The Tennessean* that he was extremely hurt by their decision.

Irate Grand Ole Opry Stars, songwriters, artists and loyal fans have all rallied together to sign a petition, started by a fan, to get Bilbrey back on the air at WSM 650 AM and onstage at the Grand Ole Opry. Renown names such as George Jones, John Conlee, Tom T. Hall, George Hamilton IV, Crystal Gayle, Jan Howard, Jamey Johnson, Sheri Easter, The Whites, etc. are among names on a list that goes on and on. Guy Gilchrist, renown comic strip artist for *Nancy & Sluggo*, was among those that are very upset with Gaylord's decision. In fact, it spurred Gilchrist to write a two page poem and draw an illustration to tell of his feelings. Gilchrist said *Nancy* is saddened by this news and shares the fears of all country fans for the future of the "Air Castle of the South" and the sacred Grand Ole Opry.

In fact, at the time this article was written, there were over 3,900 irate fans that had signed the petition (many adding their feelings) that will be given to the Gaylord CEO Colin Reed and other Gaylord management. It

is with hope that the upcoming Gaylord shareholder's meeting will turn things around for WSM Radio station and Grand Ole Opry since a Texas billionaire has now taken control of 22% of their stock. Earlier in the year, Reed was forced to sell the Gaylord's corporate jet because of his unexplained trips to Brazil and various places such as his personal farms in various states.

At a recent Daily & Vincent CD Release Party, held at the Country Music Hall of Fame, Bilbrey was recognized in the audience filled with music industry folks and was given a standing ovation.

Many of us remember Bilbrey, not only at WSM 650 and the Grand Ole Opry, but as the weatherman for 22 years on WSMV-TV Channel 4 and a regular on the Ralph Emery Show.

As many fans will miss his voice on WSM 650 and the Opry, they can still tune in to his syndicated show, *Classic Country Today*, that is in approximately 150 stations across the U.S. Locally, it can be heard on Lewisburg's WJMM's 94.3 FM on Sundays from 8 pm - 10 pm.

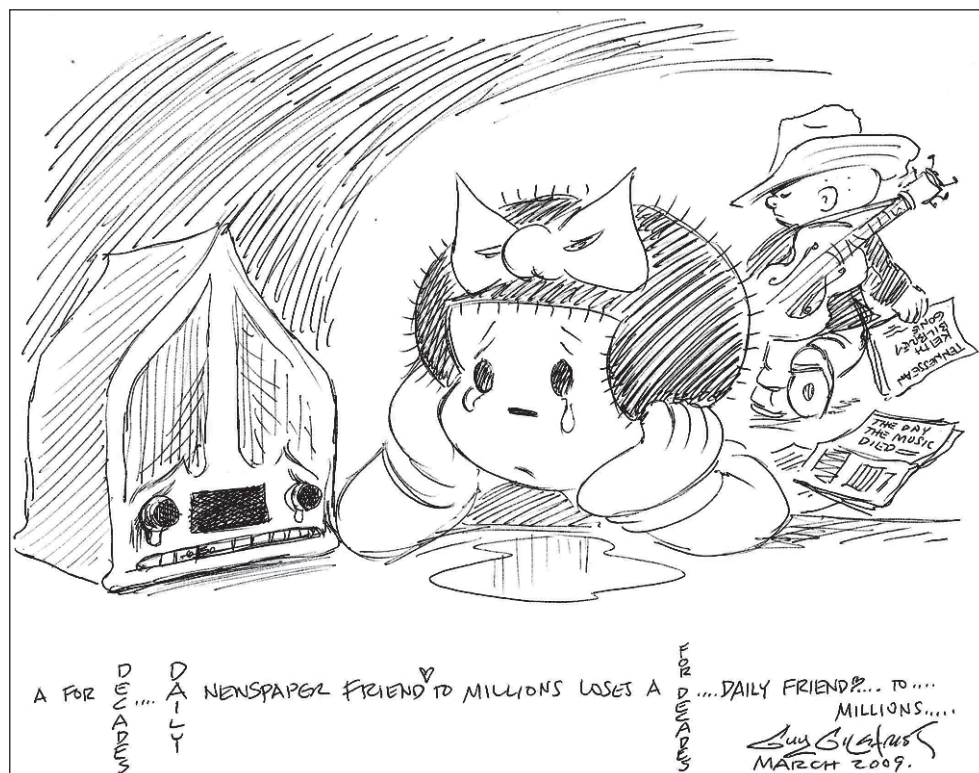

## USDA Announces Disaster Assistance for Producers

Buy-In Waiver Extended for Those Impacted by Natural Disasters

Nashville, TN, March 25, 2009 - The recently approved American Recovery and Reinvestment Act of 2009 (ARRA) allows producers to become eligible for 2008 disaster assistance authorized by the 2008 Farm Bill even if they did not previously obtain otherwise statutorily required crop insurance from the Federal Crop Insurance Corporation (FCIC) or Non-insured Crop Disaster Assistance Program (NAP) coverage for 2008 by now paying a buy-in fee through May 18, 2009.

"This is an opportunity for producers who suffered losses as a result of natural disaster. This will help them as they are going through tough times and will also help them stimulate the economy and create jobs," said USDA Farm Service Agency County Executive Director Eyvonne L. Haynes.

Paying such a buy-in fee does not provide the producer with crop insurance or NAP for the 2008 crop year; it merely permits the producer to become eligible for the 2008-crop disaster assistance programs.

Producers who have not already taken the necessary steps to become eligible for the Supplemental Revenue Assistance Program (SURE), Emergency Assistance for Livestock, Honeybees, and Farm-Raised Fish (ELAP), and the Tree Assistance Program (TAP) may now become eligible for such programs by completing the following steps by May 18, 2009:

Paying a \$100 buy-in fee per crop. The

maximum fee for insurable or non-insurable crops is \$300 per county, per producer, not to exceed \$900 for multi-county producers.

In the case of each insurable crop (those for which insurance is available from FCIC), excluding grazing land, agreeing to obtain a policy or plan of insurance for the next insurance year for which crop insurance is available; coverage level should equal 70 percent or more of the yield at 100 percent of the price.

In the case of each non-insurable crop, agreeing to file the required paperwork and pay the applicable administrative NAP coverage fee by the applicable state application closing date for the next available year.

### Disaster Assistance - Buy-in Extended

Producers who choose to buy in under this provision will be considered, for insured crops for the 2008 Farm Bill disaster assistance programs only, to have obtained a policy or plan of insurance for the 2008 crop year at a level of coverage not to exceed 70 percent of the yield at 100 percent of the price. For non-insurable crops for the 2008 Farm Bill disaster programs only, producers will be considered to have a level of coverage equal to 70 percent of the yield. These levels of coverage will be used to calculate the 2008 SURE guarantee. Producers who buy in will not be eligible for actual crop insurance or NAP benefits for the 2008 crop.

Producers who meet the definition of "Socially Disadvantaged, Limited Resource," or "Beginning Farmer or Rancher," are not required to pay the buy-in fee.



## Little Stories About You & Me

### Perfume

At first glance, "Perfume" by Patrick Suskind is a strange book indeed. The subtitle is even, "The Story of a Murderer."

The time was right for renewal. "People could brazenly call into question the authority of God's church...to describe God Himself, the Almighty, Very God of Very God, as dispensable to maintain in all earnestness that order, morals and happiness on this earth could be conceived of without Him, purely as matters of man's inherent morality and reason. . . God, good God! - then you needn't wonder that everything was turned upside down, that morals had degenerated, and that humankind had brought down upon itself the judgment of Him whom it denied." (*Perfume*, p. 67-68.)

Righteous people are seeking something beyond themselves when a symbolic little man of insignificance is born in the marketplace under a table and left to die. He is raised by a series of wet nurses and has nothing to call his own except an incredible sense of smell. Grenouille, as he comes to be called, could decipher the essence of anything. He becomes a perfumer. "He provided recipes for all the perfumers of France without once repeating himself, without once producing something of inferior or even average quality." (*Perfume*, p. 105.) He spends seven years in exile where he gives up his own odor. He stands naked at the entrance to the cave where he had lived, void of odor—void of self. Later he takes the lives of beautiful young virgins as he takes their essence into himself, collecting them to make the perfect scent. When he is convicted of murder and sentenced to die by crucifixion and actually goes to the cross, he comes down from the cross pardoned. His fate however is not as you might expect. He does not live happily ever after. Ultimately, he is eaten by his

admirers as they take him into themselves. "They were all a little embarrassed and afraid to look at one another. They had all, whether man or woman, committed a murder or some other despicable crime at one time or another. But to eat a human being? . . . All of a sudden there were delightful, bright flutterings in their dark souls. . . For the first time they had done something out of Love." (*Perfume*, p. 295-296.)

Now is this not a familiar story? Jesus Christ (God Himself), at a time when people were searching for something outside of themselves, was born in a busy city, under the clamor of tax collecting in perhaps a cave and raised by surrogate parents. The time was right for renewal, for a new covenant. Jesus discerned everyone and loved people as no one had before. God, the creator has not once repeated Himself and has never made anything that is inferior. Only God is perfect. He can take our most beautiful children in death and still we love Him. Jesus Christ spent time in the wilderness away from His admirers and when He emerged He was crucified on a tree only to be raised from the dead.

Even today we take the Eucharist. Jesus took the bread and broke it and said, "Take, eat; this is my body." And he took a cup, and when he had given thanks he gave it to them, saying, "Drink of it, all of you; for this is my blood of the covenant, which is poured out for many for the forgiveness of sins. (Holy Bible, Matthew 26:26-28) Yes, we do remember Jesus Christ going to the cross to pay for our sins. Only God can take care of our sins. We cannot do that for ourselves. When we take Christ into ourselves, we too can become like Him, without essence or self.

"Perfume," as strange as it may seem, was made into a movie bringing in \$135,000,000.00 worldwide. If you read the book or see the movie, I hope you don't miss the message—a familiar story that has been around for more than 2000 years.

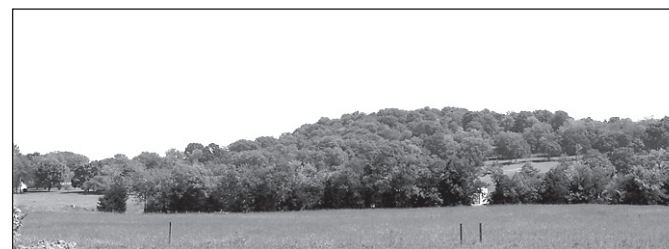

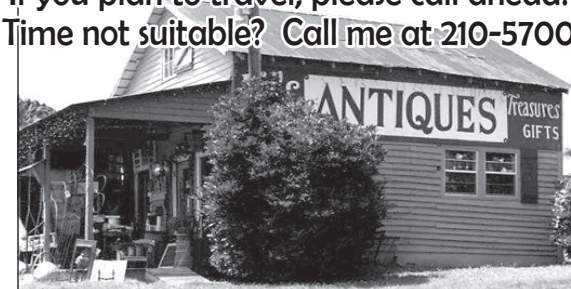
