MURFREESBORO, Tenn. – Usher in the holiday season with an enchanting tour of historic homes and landmarks. The annual Oaklands Christmas Candlelight Tour of Homes is slated for December 7, 2013, from 4:00 p.m. – 8:00 p.m. in Murfreesboro, Tennessee. The tour, sponsored by Oaklands Association and MidSouth Bank, will feature beautiful and historic private homes along East Main Street, a distinctive church, and the graceful Oaklands Mansion.

Betty Hord, President of Oaklands Association, said “Visiting the festively appointed homes on our Candlelight Tour is a favorite way to begin the celebration of the holidays”.

The cornerstone of the tour is the grand Oaklands Mansion. Historical interpreters in period attire will guide you

through the fascinating story of this gracious mansion. At its peak, Oaklands was the center of a 1,500 acre plantation and one of the most elegant homes in Middle Tennessee. Since that time, Oaklands has seen dramatic changes. Following the Civil War, it deteriorated from a majestic mansion to virtual ruins and, in the 1950’s, its very existence was threatened. The mansion was brought back from the brink of destruction and saved from the wrecking ball when a group of concerned ladies created Oaklands Association in 1959. Since that time, the Association has worked tirelessly to restore Oaklands to its original splendor and preserve its unique history.

Today, local residents and visitors alike enjoy the mansion

that has been lovingly restored and brought back to its former glory. The proceeds of the Candlelight Tour of Homes go toward the care and preservation of this historic treasure. Admission is \$10.00 per person 21 years and older, students \$8 .00, ages 6-12, \$5.00, ages 5 and under are free. 1 c vegetable oil
2 c sugar
3 eggs
3 c flour
1 tsp baking soda
2 tsp vanilla extract
1 c chopped pecans
3 c peeled and chopped apples

Preheat oven to 350 degrees. Grease a 9 x 13" pan. Combine oil, sugar, and eggs. Stir in flour and baking soda. Add vanilla, pecans, and apples. Spread in prepared pan and bake for 45-50 minutes. Cool for 2 hours. Then prepare frosting.

Frosting: 1/2 c butter
1 c brown sugar, packed
1/4 c evaporated milk
1/2 tsp vanilla

Boil all ingredients in a small saucepan for 2 minutes. Set pan in bowl filled with ice water. Beat icing until of spreading consistency. Spread over top of cake.

JUDGE SISKIN ANNOUNCES CANDIDACY TO RETAIN CIRCUIT COURT SEAT

Murfreesboro, Tenn. - Keith Siskin, Judge of Division III of the Circuit Court for Rutherford and Cannon Counties, has officially announced his candidacy for election to retain his seat on the Court.



Judge Siskin, a Republican, was appointed to the Circuit Court by Governor Bill Haslam in 2012 following an extensive public interview process by the nonpartisan Tennessee Judicial Nominating Commission. During the public interview process, Judge Siskin received the highest rating of all applicants by the Rutherford/Cannon County Bar Association. Prior to his appointment as Circuit Judge, Siskin served as Magistrate and Referee of the Rutherford County Juvenile Court for eight years, and previously practiced law in Murfreesboro.

Since taking office last year, Judge Siskin's top priority has been making the Court more open and accessible to the public. To that end, Judge Siskin has launched a website for the Court that allows members of the public to download Court-approved forms, and to research statutes and rules applicable to their cases. Judge Siskin pointed out that the website was developed with jurors in mind, as it contains an interactive parking map, as well as a section containing daily announcements, such as weather closings and docket changes; additionally, jurors can now view the Judge's sentencing decisions online, a first for this judicial district. "I am a firm believer in open government, and that includes our Courts," Judge Siskin said. "The framers of the Tennessee

Constitution envisioned trial judges who were elected by the people and answerable to the people."

Judge Siskin further announced that Tracey Binkley, CRPC, CFP, will serve as his campaign treasurer. Binkley, a Financial Advisor with Morgan Stanley Wealth Management in Murfreesboro, has been in the financial services business for nearly 20 years both in banking and investment management.

Judge Siskin is an active member of the community, having volunteered with both the Murfreesboro Evening Lions Club and Murfreesboro Noon Lions Club, and having served as past president of the Rutherford/Cannon County Bar Association.

A native of Savannah, Georgia, Judge Siskin is a graduate of Vanderbilt University and the University of Georgia School of Law, where he served as Editor-in-Chief of the Georgia Journal of International and Comparative Law. Judge Siskin resides in the Blackman Community of Murfreesboro with his wife, Sheri, and step-daughters, Micah and Shae.
